Declaration of Conformity to European Union Directive 1907/2006 REACH (SVHC 235)

Cerro Flow Products LLC's Declaration of Conformity represents that all duties under the European Union regulation no. 1907/2006 Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) have been fulfilled; including the disclosure of Substances of Very High Concern (SVHC) according to Article 33.

As of the date of this Declaration, Cerro Flow Products LLC's CerroTube products contain none of the substances in the:

- Authorization List of substances included in REACH Annex XIV.
- Candidate List of Substances of Very High Concern (SVHC).
- Constituents List under REACH Annex XVII: REACH Restricted Substance List.

REACH Article 33

Duty to communicate information on substances in articles

1. Any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59 (1, 10) of Regulation (EC) No. 1907/2006 in a concentration above 0.1 % weight by weight (w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance.

REACH Annex V

Registration is not required for substances: Occurring in nature (e.g. minerals, ores and ore concentrates that are not chemically modified) where registration is deemed inappropriate or unnecessary.

ANNEX V

EXEMPTIONS FROM THE OBLIGATION TO REGISTER IN ACCORDANCE WITH ARTICLE 2(7)(b)

7. The following substances which occur in nature, if they are not chemically modified: Minerals, ores, ore concentrates, raw and processed natural gas, crude oil, coal.

REACH Definition

Article 3 (41), alloy: means a metallic material, homogenous on a macroscopic scale, consisting of two or more elements so combined that they cannot be readily separated by mechanical means.

Copper alloys combine various metals in a homogenous alloy. Copper alloys are not chemically modified and as such, are exempt from REACH. The manufacture of copper tube is a physical change, not a chemical change. Cerro Flow Products LLC's copper tubing is comprised of UNS C12200 99.9% copper alloy of naturally occurring metals. Thus, Cerro Flow Products LLC declares that CerroTube products are exempt from registration requirements of REACH.

REACH Definition

Article 3 (3), article: means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition;

Article 7(1) requires Producers and Importers of products to register with the ECHA chemical substances that are intentionally released from the products during use.

Cerro Flow Products LLC declares that CerroTube products do not intentionally release substances into the environment. CerroTube products comply with limits described in:

Article 57 and identified in accordance with REACH Regulation (EC) Article 59

Cerro Flow Products LLC declares that CerroTube products do not contain any substances of very high concern (SVHC) above the specified limits.

Cerro Flow Products LLC will monitor the Candidate List as part of our on-going effort of compliance, including the possible need under Article 33 of REACH to inform product recipients and consumers if an article contains more than 0.1% by weight of a substance added to the SVHC candidate list in the future.

Cerro Flow Products LLC representations herein are based on chemically evaluation of CerroTube finished goods by NSF and certification as NSF 61 compliant for the listed substances. Safety Data Sheets (SDS) provided by suppliers of lubricants and cleaners used in the production of CerroTube, and "Quality Certificates of Analysis" provided by our raw material (copper) supplier, list no substances above REACH specified limits.

Cerro Flow Products LLC representations herein do not include disclosure of the existence of "impurities," defined for purposes of this certification as chemical substances unintentionally present and not for the purpose of imparting or changing the characteristics of a material or product.

Since conditions of use are outside Cerro Flow Products LLC control, Cerro Flow Products LLC makes no warranties, express or implied, and assumes no liability related to any use of this information.
